

ORDINANCE NO. 1410-2007

AN ORDINANCE ENLARGING AND EXTENDING THE BOUNDARIES
OF THE CITY OF PINEVILLE, LOUISIANA, PURSUANT TO THE
ASSENT OF THE PROPERTY OWNERS AND TAXPAYERS
WITHIN THE AREA PROPOSED TO BE INCLUDED WITHIN THE
CORPORATE LIMITS; DESCRIBING AND DEFINING SAID TERRITORY
PROPOSED TO BE INCLUDED IN THE CORPORATE LIMITS

WHEREAS, a petition has been presented to the Mayor and Council of the City of Pineville, Louisiana containing the written assent of a majority of the registered voters and a majority in number of the resident property owners as well as twenty-five (25%) percent in value of the property of the resident property owners within the area described below, requesting that same be taken into the City of Pineville, and

WHEREAS, notice of said petition has been given by publication in the Alexandria Daily Town Talk on the 27th day of November, 3rd day of December and the 10th day of December 2007.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Pineville, Louisiana in legal session convened, and after a public hearing held this date, that:

1.

The boundaries of the corporate limits of the City of Pineville be and are hereby enlarged and extended to include the following described territory, to-wit:

PARCEL I

A certain piece, parcel or tract of land, together with all buildings and improvements thereon and being a portion of Lots 22 and 23 of Oak Ridge Subdivision Recorded in Plat Book 7, Page 147 records of Rapides Parish, Louisiana, and being more particularly described as follows, to-wit:

Begin at the northeast corner of Lot Twenty Three of Oak Ridge Subdivision, thence from the POINT OF BEGINNING run south along the western boundary line of Military Highway a distance of ninety two and 1/10th (92.1) feet; thence back from said Military Highway in a westerly direction to a point on the rear line of Lot Twenty Two (22) of said Oak Ridge Subdivision a distance of two hundred and three (203) feet more or less; thence northerly along the rear line of Lot 22 a distance of fifty (50) feet to the northwest corner of said lot which is common to Lots Nineteen (19), Twenty Two (22) and Twenty Three (23) of said Oak Ridge Subdivision; thence along the north line of Lot Twenty Three (23) a distance of two hundred nineteen and 5/10ths (219.5) feet back to the POINT OF BEGINNING.

PARCEL II

A certain piece, parcel or Tract of land, together with all buildings and improvements, thereon being and lying in the Southwest 1/4 Section 36, Township 5 North, Range 1 East, Rapides Parish, Louisiana, and being more particularly described as follows, to-wit:

Begin at a point on western boundary line of Military Highway at a point where the southern line of the SW 1/4 of Section 36, Township 5 North, Range 1 East intersects said Highway; Thence run along the western Boundary Line of said Highway in a northerly direction a distance of 100 feet to a point; Thence from the points thus established, run west away from the Highway and between parallel lines a distance of 200 feet, thus forming a plot of land 100 feet on said highway and running back between parallel lines 200 feet.

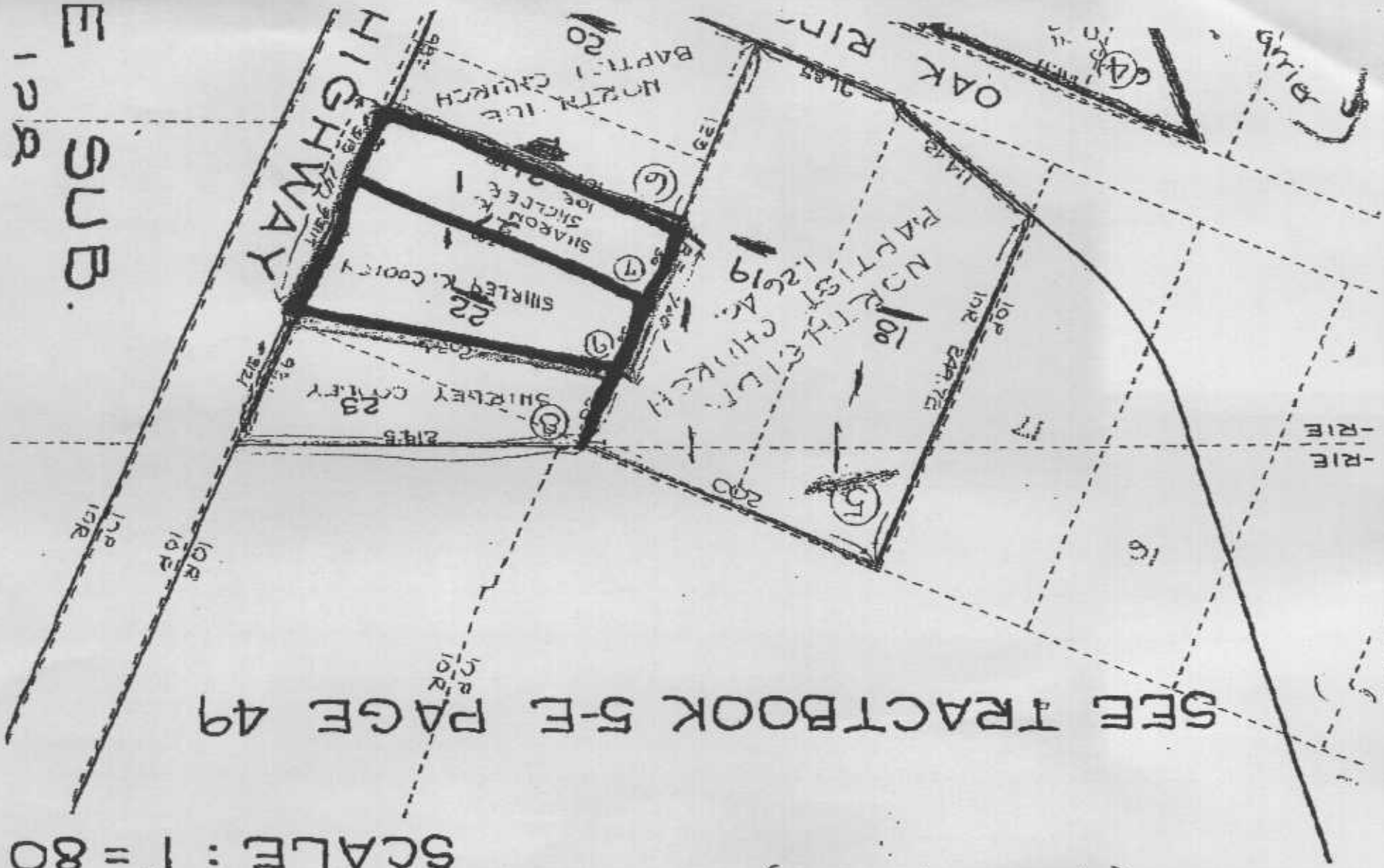
